- Develops and prepares program of activities, documentation, and materials needed for facilitating trainings/workshops, in consultation with the ACP Coordinator and/or ACP Staff
- Participates in the review of current modules and development of new training programs that are also based on assessed needs of partner organizations
- Facilitates and/or conducts workshops to partner organizations
- Assists in strengthening existing networks catering to the protection of children, thru the provision of technical assistance
- Evaluates the effectiveness of trainings conducted to partner organizations
- Prepares reports regarding completed activities and other related program documentation
- Assists in documentation, administration and coordination work
- Strategizes, plans, and prepares budgets for new advocacy activities and trainings
- Represents Stairway in inter-agency council and/or partnership meetings
- Observes all organizational policies and procedures and abides by our Child Protection Policy at all times
- Fulfills any other duties deemed necessary as assigned by the SFI NCR Head and/or SFI Executive Director
